Tiered Points Race Q1

Official Rules

1. Eligibility.

Tiered Points Race Q1 is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino (“PH&C) Banned Patron List. Must have a valid Diamond, Emerald, Sapphire or Topaz Fire Keeper’s Club® card to enter; membership is free. Employees of PH&C are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The Promotion period starts at 12:00a.m Central Time (CT) and ends at 11:59pm CT every Monday, from October 3rd through December 26th, 2022. PH&C’s computer is the official time-keeping device for this Promotion.

4. How to Enter.

Qualified guests are eligible to play during the dates described above. Guests must use their player’s card to earn points during the Promotion Period. All guests who earned points will be ranked within their Tier at the end of each week / month to determine prizes.

Weekly race - based on tier as of that Monday at midnight.

Monthly race - based on tier as of 1st Monday of the month at midnight.

All games where points are earned are eligible. Only base points will count.

Must be present to earn points. No mechanically reproduced entries will be permitted. All entries become the property of PH&C and will not be returned.

5. Free Entry. N/A

6. Drawing and Notification.

- Special website will feature live rankings for the week and month for eligible guests.
- Guests need not be present to win.
- Each Tier only competes within their individual Tier.

- Only ratings that start after 12:00am and end before 11:59pm on Mondays will count.
- If a player moves up a Tier, they will qualify for the monthly prize of the Tier they are in at the start of the month.
- If a player becomes banned during the month, they become ineligible for the monthly prizes
- If there are any ties at any of the prize breaks, the prizes will be added together and divided equally amongst the guests that tied for the prize.
- Reward Play will be added on each Tuesday no later than 5pm and is good through 11:59pm on the following Sunday.
- Odds of winning a prize depend on the number of eligible guests that participate.
- PH&C has the sole authority to determine the winners and such decisions are final.

9. Release, Publicity, Use of Personal Information.

10. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
