Official Rules

1. Eligibility.

The **Poker Room's "Twilight Cash Giveaway"** is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Employees of Potawatomi Hotel & Casino ("PH&C") and the immediate family members of the Marketing Department, Player Development Department and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.

3. Promotion / Qualification Period.

The qualification period for **The Poker Room's "Twilight Cash Giveaway"** continues 12am January 1st Central Time (CT), and ends at 5am; each Monday through Friday morning during the month of January 2019.

PH&C's computer is the official time-keeping device for this Promotion.

4. How to Enter.

- Guests must be or become a Fire Keeper's Club member to receive prize
- Any player who is seated at 12am at a live action Texas Hold'em game will receive one free ticket into the Twilight Cash Tumbler, from then on any player who shows the dealer a hand of a full house or better using both hole cards on a live action Texas Hold'em, will receive an additional ticket for that days' tumbler.
- Guests must be present and playing in a live action Texas Hold'em game at the time of drawing.
- Guests are eligible to win more than once per promotion date.

How it works / “Twilight Cash Giveaway”

- Any player who is seated at 12am at a live action Texas Hold'em game will receive one free ticket into the Twilight Cash Tumbler, from then on any player who shows the dealer a hand of a full house or better using both hole cards on a live action Texas Hold'em, will receive an additional ticket for that days' tumbler drawing.
- **Drawing Times and Prizes:**
 - 2am - \$100
 - 3am - \$150
 - 4am - \$200
 - 5am - \$250
- **Must be present to win** / Guests must be playing in a live action Texas Hold'em game at the time of drawing.
- Winner will have 5 minutes to claim their prize
- Any unclaimed prizes will carry over to the next hourly drawing.
- At the 5am drawing one name will be pulled until there is a winner.
- Guests are eligible to win more than once per promotion date.
- Guests must be or become a Fire Keeper's Club member to receive prize
- Odds of winning a prize depend on the number of qualifying hands received.
- PH&C has the sole authority to determine the winners and such decisions are final.
- *No mechanically reproduced entries will be permitted.*
- *The Tumbler will be emptied at the end of the drawing day.*
- *All entries become the property of PH&C and will not be returned.*

7. Prizes. 4 Prizes per Daily Session (Bad Beat Funds)

Unclaimed Prizes Rollover and are added to the next hour's drawing. The 5am drawing will continue to draw names until there is one final cash winner. If there are no live games running at the final 5am drawing, those funds will be returned to the Poker Bad Beat promotional funds.

Total Daily Prizes: \$700

Total Promotional Prizes: \$16,100 Bad Beat Funds (\$700 per day) x 23 daily prizes.

Please note: The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded “As Is.” Any costs or repairs become the responsibility of the winners. Items are not redeemable for cash.

W-9 form must be filled out for any cash/trip/prize over \$50. Winner must present a valid ID and Fire Keeper's Club card to claim prize. A valid ID includes any government-issued ID such as a driver's license, passport or state ID card.

8. Prize Acceptance/Restrictions.

The winners will be required to provide valid picture identification and a Fire Keeper’s Club card to claim prize. Prizes are not transferrable or assignable. No substitution allowed except by PH&C, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

9. Release, Publicity, Use of Personal Information.

Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

10. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
