### Poker Room's High Hand "Cash Giveaway" January 2019 Official Rules

#### 1. Eligibility.

The Poker Room's High Hand "Cash Giveaway" is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Employees of Potawatomi Hotel & Casino ("PH&C") and the immediate family members of the Marketing Department, Player Development Department and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

#### 2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.

#### 3. Promotion / Qualification Period.

The qualification period for The Poker Room's High Hand "Cash Giveaway" begins at 8am Central Time (CT), and ends at 5:59pm each Monday through Thursday during the month of January. The Promotion begins on Tuesday, January 1<sup>st</sup> 2019 and ends on Thursday, January 31<sup>st</sup> 2019. PH&C's computer is the official time-keeping device for this Promotion.

#### 4. How to Enter.

- All guests must be Fire Keeper's Club Members at the time of entry.
- Guests must be in a live action Texas Hold'em game.
- Any high ranking poker hand achieved by a FKC member playing in a live Texas Hold'em game during each qualifying session will have his/her name recorded on the board. At least a Full House to qualify
- Any new high hand must beat - Not Tie – the previous high hand.
- Qualifying High Hands will reset for each half-hour session.
- FKC Members are eligible to win more than once per promotion date

*Must be present to win. No mechanically reproduced entries will be permitted. All entries become the property of PH&C and will not be returned.*

### How it works / “High Hand”

#### Sessions: Monday, Tuesday, Wednesday, Thursday

- **8am – 5:59pm**
- Entrants must be present to win.
- Qualifying “High Hand” must have both hole cards play, be verified by the dealer and a floor person must be notified to verify the hand.
- “High Hand” Name and Qualifying “High Hand” will be posted in the Poker Room
- “High Hand” holder must be playing in a Texas Hold’em game to win at the end of each session.
- Each “High Hand” Session will be worth \$100
- Promotion will end for that day after the 5:59pm session.
- Odds of winning a prize depend on the number of qualifying hands received. PH&C has the sole authority to determine the winners and such decisions are final.
- Any unclaimed prizes will be rolled into the next high hand session.
- Qualifying “High Hand” holders are eligible to win multiple sessions.

## 7. Prizes. (Bad Beat Funds)

- **\$100 – Every half hour**

**Total Daily Prizes: Maximum - \$2,000**

**Total Promotional Prizes: \$38,000 (19 Days x \$2,000)**

**Please note:** The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded “As Is.” Any costs or repairs become the responsibility of the winners. Items are not redeemable for cash.

**W-9 form** must be filled out for any cash/trip/prize over \$50. Winner must present a valid ID and Fire Keeper’s Club card to claim prize. A valid ID includes any government-issued ID such as a driver’s license, passport or state ID card.

## 8. Prize Acceptance/Restrictions.

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. The winners will be required to provide valid picture identification and a Fire Keeper’s Club card to claim prize. Prizes are not transferrable or assignable. No substitution allowed except by PH&C, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

## **9. Release, Publicity, Use of Personal Information.**

Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

## **10. General Conditions.**

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
