Reel Random Jackpots

Official Rules

- 1. Eligibility.** **Reel Random Jackpots** is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Employees of Potawatomi Hotel & Casino (“PH&C”) are not eligible to participate in this jackpot program.
- 2. Agreement to Official Rules.** By participating in the jackpot program, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to this jackpot program.
- 3. Jackpot Period.** The jackpot period starts at 12:01 a.m. Central Time (CT) on Sundays between July 8th, 2018 and August 26th, 2018 and ends at 11:59 p.m. CT those same Sundays (the “Jackpot Period”). PH&C’s computer is the official time-keeping device for this jackpot program.
- 4. How to Enter.**
Reel Random Jackpots are available to all guests who are playing on an eligible slot, video poker or electronic table games slot machine during the Jackpot Period. A Fire Keeper’s Club card is not required to participate in this promotion. Any wager played in an eligible machine could trigger a Reel Random Jackpot.

Must be present to win.

- 5. Free Entry.** No purchase necessary, purchase will not increase your chances of winning. Void where prohibited.
- 6. Drawing and Notification.**
There are four levels of Reel Random Jackpots:
 - Level 1 – A fixed jackpot in the amount of \$5,000 cash (slot attendant will assist)
 - Level 2 – A fixed jackpot in the amount of \$1,000 cashable slot credit (automatically downloaded to machine once guests confirms jackpot)
 - Level 3 – A fixed jackpot in the amount of \$500 cashable slot credit (automatically downloaded to machine once guest confirms jackpot)
 - Level 4 – A fixed jackpot in the amount of \$250 cashable slot credit (automatically downloaded to machine once guest confirms jackpot)

Guests must be present to win. Winners are chosen at random from all active slots, video poker and electronic table game players, regardless of the denomination or length of time they play. Reel Random Jackpots are completely independent of the machine's game outcome; guest does not need a winning combination on the machine. When a Level 1 Reel Random Jackpot happens, guests must stay at their machine until the win has been verified. A slot attendant will notify the guest playing at the randomly chosen machine that they may be a winner. Reel Random Jackpots are non-transferable. Odds of winning a prize depend on the number of eligible players. PH&C has the sole authority to determine the winners and such decisions are final. Guests can win more than once.

Approximate Retail Value: Dependent on slot, video poker and electronic table game machine activity

Please note: The winners of any and all prizes are responsible for any applicable taxes or fees. All prizes are awarded "As Is." Any costs or repairs become the responsibility of the winners. Items are not redeemable for cash. Level 1 Reel Random Jackpot winners will have to present a valid ID and second form of identification to claim prize. A valid ID includes any government-issued ID such as a driver's license, passport or state ID card.

7. **Prize Acceptance/Restrictions.** Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. Prizes are not transferrable or assignable. No substitution allowed except by PH&C, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.
8. **Release, Publicity, Use of Personal Information.** By accepting a Reel Random Jackpot, guest will complete form that grants PH&C permission to take and use their photograph, name or likeness in any of PH&C's advertising and/or publicity purposes at no additional compensation.
9. **General Conditions.** In the event that the operation, security, or administration of the jackpot program is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the jackpot program to address the impairment and then resume the jackpot program in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the jackpot program and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the jackpot program or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the jackpot program may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. Limitations of Liability and Release. Entrants agree to release and hold harmless Potawatomi Bingo Casino, Potawatomi Hotel, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors and employees of each of them (“the Released Parties”) from and against any claim or cause of action arising out of participation in the jackpot program, or acceptance or use of any prize, including but not limited to: (a) unauthorized human intervention in the jackpot program; (b) technical errors related to computers, servers, EGMs, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the jackpot program or the processing of registrations and game plays; (e) late, lost or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the jackpot program or acceptance and use of any prize. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
