30th Anniversary Kiosk Game

Official Rules

- 1. Eligibility. 30th Anniversary Kiosk Game** (the “Promotion”) is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Must have a valid Fire Keeper’s Club card to enter; membership is free. This is a kiosk promotion that is open to all Fire Keeper Club members. Employees of Potawatomi Hotel & Casino (“PH&C”) are not eligible to participate in the Promotion.
- 2. Agreement to Official Rules.** By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.
- 3. Promotion Period.** The Promotion Period starts at the kiosks on 12:00 a.m. Central Time (CT) on March 1st and ends at 11:59 p.m. CT, on March 31st, 2021 (The “Promotion Period”). There will be a drawing on April 5th, 2021. PH&C’s computer is the official time-keeping device for this Promotion.
- 4. How to Enter.** All Fire Keeper’s Club members may play the game. After earning 200 same-day points; guests must swipe their Fire Keeper’s Club card into any promotional kiosk, enter pin number, select Monthly Promotions and then touch “30th Anniversary Kiosk Game”. Game is valid 12:00 a.m. to 11:59 p.m. every day in March 2021 only. No mechanically reproduced entries will be permitted. All entries become the property of PH&C and will not be returned.
- 5. Free Entry.** No purchase necessary. Void where prohibited. Any Fire Keeper’s Club Member may attain one free entry into the drawing by sending a 3” x 5” card with their name, complete address including zip code (no P.O. boxes), daytime phone number with area code, and date of birth, in an envelope to: 30th Anniversary Kiosk Game Promotion Free Entry, 1721 W. Canal St., Milwaukee, WI 53233. PH&C will not honor damaged, late, illegible, incomplete, or copied entries. Entries must be received by April 4th to be considered eligible.
- 6. Drawing and Notification.**
 - **Kiosk** – After earning 200 same-day points, guests can play the 30th Anniversary Kiosk Game kiosk game and have a chance to win Reward Play or drawing tickets in March 2021. Guests need to be present to win. Guests can earn up to ten (10) spins each day during the promotion. To play the game after earning required points, guests need to touch the numbered wheel in the top right corner each time they visit the kiosk. During each available spin earned, they will move

through the board game by the number of spaces landed on the numbered wheel. Spins need to take place at the kiosks on the same day as they are earned; 200 points per spin. Guests will continue on their game board from where they left off on their previous visit. Points earned towards the promotion are base points only. Reward Play from the kiosk game is good for 7 days after redemption.

- **Drawing** – There will be a Need Not be Present to Win drawing in connection with the kiosk game held on Monday, April 5th, 2021. The only way to earn drawing tickets is by participating in the 30th Anniversary Kiosk Game. Winners will be contacted by a PH&C employee and have 14 days to respond; otherwise alternate winners will be drawn. PH&C has the sole authority to determine the winners and such decisions are final.

7. Prizes. Prize includes the following:

- Kiosk prizes range from \$5 - \$1,000 Reward Play & 25 – 1,000 drawing tickets
 - i. Prizes will vary depending on the Prize Wheel outcome
 - ii. Prize Wheel is activated when the player lands on or crosses the designated spaces with a Bonus Game marking on the game board
 - Spaces 7 – 14 – 20 – 28 – 35 – 42 – 49 – 55
 - iii. Prizes will also be awarded for crossing the start/finish line on the game board (called Laps in the game)
 - Lap 1 & 2 \$25 Reward Play
 - Laps 3 – 6 \$50 Reward Play
 - Laps 7 – 10 \$75 Reward Play
 - Laps 11 – 14 \$100 Reward Play
 - Laps 15 – 18 \$150 Reward Play
 - Laps 19+ \$200 Reward Play
- Drawing prizes are as follows (21 Total)
 - i. Twenty (20) runner-ups winning \$3,000 Reward Play (Good for 30 Days)
 - ii. One (1) Grand Prize Winner (first name drawn)
 - 2021 Cadillac XT5 (valued at \$58,200) or
 - \$40,000 Cash Option

Please note: The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded “As Is.” Any costs or repairs become the responsibility of the winners. Items are not redeemable for cash.

W-9 form must be filled out for any cash/trip/prize over \$50. Winner must present a valid ID and Fire Keeper’s Club card to claim prize. A valid ID includes any government-issued ID such as a driver’s license, passport or state ID card.

- 8. Prize Acceptance/Restrictions.** Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The winners may be required to provide valid picture identification and a Fire Keeper’s Club card to claim prize. Prizes are not transferrable or assignable. No substitution allowed except by PH&C, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be

contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

9. Release, Publicity, Use of Personal Information. Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

10. General Conditions. In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

11. Limitations of Liability and Release. Entrants agree to release and hold harmless Potawatomi Bingo Casino, Potawatomi Hotel, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors and employees of each of them ("the Released Parties") from and against any claim or cause of action arising out of participation in the Promotion, or acceptance or use of any prize, including but not limited to: (a) unauthorized human intervention in the Promotion; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Promotion or the processing of registrations and game plays; (e) late, lost or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or acceptance and use of any prize. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
