### Official Rules

#### 1. Eligibility.

The Poker Room's "Royal Flush Giveaway" is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Employees of Potawatomi Hotel & Casino ("PH&C") and the immediate family members of the Marketing Department, Player Development Department and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

#### 2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.

#### 3. Promotion / Qualification Period.

The qualification period for The Poker Room's "Royal Flush Giveaway" continues on Tuesday January 1<sup>st</sup> 2019 at 12am Central Time (CT), and ends on Thursday January 31<sup>st</sup> 2019 at 11:59pm. (Rollover Boards being updated weekly) PH&C's computer is the official time-keeping device for this Promotion.

- Qualifying Players must be playing in a live Texas Hold'em game.
- Guest must be the first to make a Royal Flush using both suited hole cards in one of the combinations listed.

#### How it works / "Royal Flush Giveaway"

- Qualifying Players must be playing in a live Texas Hold'em game.

- Qualifying “Royal Flush Hand” must have both hole cards play, be verified by the dealer and a floor person must be notified to verify the hand.
- Royal Flush Prizes will be posted in the Poker Room
- The first qualifying hand of each Royal Flush Combination will be paid out and crossed off the board.
- Any unclaimed prizes will rollover to the next week’s board / claimed prizes will reset at \$250
- The board resets every Monday at the start of each promotional week.
- All prizes unclaimed by January 31<sup>st</sup> at 11:59pm will go back into the bad beat promo funds.
- Prizes will remain available if Promotion is extended.
- Guests are eligible to win more than once per promotion date.
- Guests must be or become a Fire Keeper’s Club member to receive prize
- Odds of winning a prize depend on the number of qualifying hands received. PH&C has the sole authority to determine the winners and such decisions are final.

**10. General Conditions.**

PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law.
