

## PROMOTIONS DEPARTMENT Early Bird Tiered Multiple Points Official Rules

- 1. Eligibility. Early Bird Tiered Multiple Points is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Must have a valid Topaz, Sapphire, Emerald or Diamond Fire Keeper's Club card to enter; membership is free. Employees of Potawatomi Hotel & Casino ("PH&C") are not eligible to participate in the Promotion.
- **2. Agreement to Official Rules.** By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.
- **3. Promotion Period.** The Promotion period starts at 8:30AM and ends at 11:59AM Time (CT) on each multiplier date. PH&C's computer is the official time-keeping device for this Promotion.
- **4. How to Enter.** Qualified Topaz, Sapphire, Emerald and Diamond guests playing slots during the first reservation session (excludes video poker slots & electronic table games) with their Fire Keeper's club card can receive 3x points. To qualify a guest must have been a Topaz, Sapphire, Emerald, or Diamond tier Fire Keeper's Club member a week prior to the event date.
