

PROMOTIONS DEPARTMENT Go Bananas June 2021 Official Rules

- 1. Eligibility. Go Bananas (the "Promotion") is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Must have a valid Fire Keeper's Club card to enter; membership is free. This is a kiosk promotion that is open to all Fire Keeper Club members. Employees of Potawatomi Hotel & Casino ("PH&C") are not eligible to participate in the Promotion.
- 2. Agreement to Official Rules. By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.
- **3. Promotion Period.** The Promotion Period starts at 12:00 a.m. Central Time (CT) on Thursdays and ends at 11:59 p.m. CT, on Saturdays in June 2021 (The "Promotion Period"). PH&C's computer is the official time-keeping device for this Promotion.

- 4. How to Enter. All Fire Keeper's Club members may play the game. After earning 250 same-day points, guests must swipe their Fire Keeper's Club card into any promotional kiosk, enter pin number, select Monthly Promotions and then touch "Go Bananas". Game is valid 12:00 a.m. to 11:59 p.m. Thursdays Saturdays in June 2021 only. No mechanically reproduced entries will be permitted. All entries become the property of PH&C and will not be returned.
- 5. Free Entry. No purchase necessary. Void where prohibited.
- 6. Drawing and Notification. After earning 250 same-day points, guests can play the Go Bananas kiosk game and win Reward Play from 12:00 a.m. on Thursdays to 11:59 p.m. on Saturdays in June 2021. Guests need to be present to win. Guests can play twice each day during the promotion. To play the game, guests need to touch the wheel in the top right corner each time they visit the kiosk. They will move through the board game by the number of spaces landed on the wheel each time. Spins need to take place at the kiosks on the same day as they are earned; 250 points per spin. Guests will continue on their game board from where they left off on their previous visit; Game does not reset and can only be played once through. Points earned towards the promotion are base points only. Reward Play is good for 7 days after redemption. PH&C has the sole authority to determine the winners and such decisions are final.

No substitution allowed except by PH&C, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.
- **9.** Release, Publicity, Use of Personal Information. Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.
- 10. General Conditions. In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Entrants agree to release and hold harmless Potawatomi Bingo Casino, Potawatomi Hotel, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors and employees of each of them ("the Released Parties") from and against any claim or cause of action arising out of participation in the Promotion, or acceptance or use of any prize, including but not limited to: (a) unauthorized human intervention in the Promotion; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Promotion or the processing of registrations and game plays; (e) late, lost or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or acceptance and use of any prize. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
