# Poker Room's "Splash the Pot" December 2016 – April 2017 Official Rules

### 1. Eligibility.

The Poker Room's "Splash the Pot" is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Must have a valid Fire Keeper's Club card to enter; membership is free. Employees of Potawatomi Hotel & Casino ("PH&C") and the immediate family members of the Marketing Department, Player Development Department and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

#### 2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.

#### 3. Promotion Period.

The qualification period for **The Poker Room's "Splash the Pot"** begins at Noon Central Time (CT), and ends at 4pm CT, each Monday and Wednesday. The promotion begins on Monday December 5<sup>th</sup> 2016 and ends on Wednesday April 26<sup>th</sup> 2017. PH&C's computer is the official time-keeping device for this Promotion

#### 4. How to Enter.

- Guests must be in a live action game.
- Only FKC members playing in a live Texas Hold'em game will be eligible to win the "Splash the Pot" Promotion.
- FKC Members are eligible to win more than once per drawing date

### How it works / "Splash the Pot"

- Each hour: (4 total)
  - (Noon 1pm) (1 2pm) (2 3pm) (3pm 4pm)
- Poker Room Management or Member from Security will randomly select one of the open tables to "Splash the Pot" with an additional \$100.
- A floor person will get \$100 in chips from the Cage
- The selected open table will then have the additional \$100 in chips "Splashed" to the Pot for any winning FKC member's hand.
- The winning hand at that table will collect the original pot;
  - ❖ If they are a FKC member they will receive the extra \$100 Splashed to the Pot
  - ❖ If not the money rolls over to the next hour's selected table
    - Winning guest has the option to sign up for FKC membership and receive prize
- Winning table becomes eligible for the next random "Splash the Pot" selection

#### 8. Prize Acceptance/Restrictions.

Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The winners will be required to provide valid picture identification and a Fire Keeper's Club card to claim prize. Prizes are not transferrable or assignable. No substitution allowed except by PH&C, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

### 9. Release, Publicity, Use of Personal Information.

The winners will be required to fill out a Promotional Prize Payment form, a W-9 tax form for any cash/trip/prize received and a Contest Prize Release/Publicity Form. Winners will be asked to allow

use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

#### 10. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Entrants agree to release and hold harmless PH&C, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors and employees of each of them ("the Released Parties") from and against any claim or cause of action arising out of participation in the Promotion, or acceptance or use of any prize, including but not limited to: (a) unauthorized human intervention in the Promotion; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Promotion or the processing of registrations and game plays; (e) late, lost or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or acceptance and use of any prize. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
