# Official Rules May 2018 Kentucky Derby Glass Giveaway

## 1. Eligibility.

**Kentucky Derby Glass Giveaway** (The "Promotion") is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Must have a valid Fire Keeper's Club card to enter; membership is free. Employees of Potawatomi Hotel & Casino ("PH&C") are not eligible to participate in the Promotion.

## 2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.

#### 3. Promotion Period.

The Promotion period starts at 10:00 a.m. Central Time (CT), May 5<sup>th</sup> 2018, and ends at 3:00 p.m. CT, May 5<sup>th</sup> 2018 or until supplies last. PH&C's computer is the official time-keeping device for this Promotion.

### 5. Gift Acceptance/Restrictions.

Guests will be required to provide valid 2018 Kentucky Derby PH&C wager ticket along with a valid picture identification and a Fire Keeper's Club card to claim gift. F&B Credit is valid for May 5<sup>th</sup> 2018 only. Guests must claim the gift on the specified date and time. If guest fails to claim gift within the required time period, s/he forfeits the gift. Gifts are provided on a first-come first-served basis while supplies last. Gifts are not transferrable or assignable. No substitution allowed except by PH&C.

#### 6. Free Entry.

No purchase necessary, purchase will not increase your chances of winning. Void where prohibited. Any Fire Keeper's Club member may obtain their one-time free **Kentucky Derby Gift Package** by filling out the **Free Entry Form** in its entirety.

### 7. Release, Publicity, Use of Personal Information.

Guests may be asked to allow use of his/her name and likeness for promotional/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

### 8. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
