Official Rules

1. Eligibility.

Refer a Friend Monday is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Fire Keeper's Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, ("PCH"). Employees of ("PCH") are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The Promotion period starts at 6 a.m. Central Time (CT), and ends at 11:59 p.m. CT, each Monday in April:

PCH's computer is the official time-keeping device for this Promotion.

How it Works:

- The existing member and the new member will both receive a \$25 dollar Reward Play offer, issued directly to their cards.
 - Guests can bring up to six (6) new members each Monday, for a total of \$150 in Reward Play
 - New Member must not have an existing account at Milwaukee OR Carter
- Guests must have a Fire Keeper's Club card to participate. If a guest does not have a card, they must sign up. Membership is free.
- Promotion is valid from 6 am to 11:59 pm each Monday in April

PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law.
