### **Poker Room's Bounty Board Bonanza December 4<sup>th</sup> – 27<sup>th</sup> 2017 Official Rules**

#### **1. Eligibility.**

**The Poker Room's "Bounty Board Bonanza"** is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Employees of Potawatomi Hotel & Casino ("PH&C") and the immediate family members of the Marketing Department, Player Development Department and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

#### **2. Agreement to Official Rules.**

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.

#### **3. Promotion / Qualification Period.**

The qualification period for **The Poker Room's "Bounty Board Bonanza"** begins at 9am Central Time (CT), and ends at 11:59pm each Monday & Wednesday during the month of December 2017. - Bounty Board Prizes will be posted in the Poker Room
- The first qualifying hand of each category will be paid out and crossed off the board.
- Any unclaimed prizes will carry over to the next board when it resets. The board will reset at the start of each promotional date.
- All prizes unclaimed by December 27<sup>th</sup> at 11:59pm will go back into the bad beat promo funds.
- Guests are eligible to win more than once per promotion date.
- Guests must be or become a Fire Keeper’s Club member to receive prize
