

# PROMOTIONS DEPARTMENT Tiered Multiple Points Q2-FY18 Official Rules

- 1. Eligibility. Tiered Multiple Points Q2-FY18 is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Must have a valid Fire Keeper's Club card to enter; membership is free. Employees of Potawatomi Hotel & Casino ("PH&C") are not eligible to participate in the Promotion.
