

PROMOTIONS DEPARTMENT Route 66 Official Rules

1. Eligibility.

Route 66 (the "Promotion") is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Must have a valid Fire Keeper's Club card to enter; membership is free. Employees of Potawatomi Hotel & Casino ("PH&C") are not eligible to participate in the entire promotion. The immediate family members of the Marketing Department, Player Development Department and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the drawing portion of the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.

3. Promotion Period. (Kiosk Game)

The Promotional periods starts at 3:00 a.m. Central Time on September 1st and ends at 11:59 p.m. CT on September 29th. PH&C's computer is the official time-keeping device for this Promotion. The kiosk portion of this promotion may continue past the stated period of time if needed.

How to Enter.

Fire Keeper's Club members can come to the casino during the Promotion Period and play the kiosk game. The first spin of the game is free (one time only). Guests who earn 100 same-day points will receive one additional spin, guests who earn 500 same-day points will receive another additional spin and guests who earn 1,000 same-day points will receive an additional final spin (max of three spins earned per day per guest). The same-day points associated with the additional spins will be evaluated in a time period from 3:00am to 11:59pm throughout the Promotion Period. Earned spins for kiosk game must be played on same day qualifying points are earned.

How it Works.

Swipe Fire Keeper's Club card into any promotional kiosk. Enter pin number and select "Route 66" promotion. "Route 66" is an electronic board game where guests attempt to travel across the USA on the road Route 66. Each time a guest plays the game, they will get to spin a wheel which will correlate to different prizes. Prizes (Section 7) are awarded accordingly. Guests receive prizes for traveling miles down the road, crossing state lines, stopping at different destinations and spelling the word "Route 66". Spelling "Route 66" is a bonus feature and is not guaranteed before finishing the game. Each turn a guest takes will award one prize. If a

guest finishes the game before the promotion period has ended, they will be able to start a new game the following day.

4. Promotion Period. (Drawings)

The Route 66 Final Drawings are on Saturday, September 29th, 2018. The Promotional period starts at 9:00 a.m. Central Time and ends at 3p.m. CT. PH&C's computer is the official time-keeping device for this Promotion.

How to Enter.

Guests can receive entries from playing the Route 66 kiosk game.

Activate Entries:

Swipe Fire Keeper's Club card into any promotional kiosk. Enter pin number and select drawings tab. Locate the appropriate drawing for that day within one (1) hour of the drawing to activate entries. Guests may also activate their entries at any slot machine. Insert Fire Keeper's Club card into any slot machine, place a minimum bet, then remove club card.

No mechanically reproduced entries will be permitted. All entries become the property of PH&C and will not be returned.

5. Free Entries.

No purchase necessary, purchase will not increase your chances of winning. Void where prohibited. Any Fire Keeper's Club member may obtain their one-time free entries into the drawings based on club tier by swiping their club card at any Promotional Kiosk. Enter pin number and select the promotions tab, and then locate the appropriate promotion for the free entry.

6. Drawing and Notification.

- Winners will be announced over PA system in Casino. Announcements are heard on the gaming floor only; PA announcements may not be heard in other areas such as Bingo, restaurants, etc.
- Winners will have 10 minutes to come to the Promotions stage; after that the time frame will be cut to 5 minutes until we get a winner.

- From 10am 2pm, after checking in, winners will assemble in the order their names were called and pick an envelope to determine their prize

If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize. Guests will only receive one prize (the highest value) per turn from the Battle Fleet kiosk game.

9. Release, Publicity, Use of Personal Information.

Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

10. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
