Tiered Multiple Points

Official Rules

- 1. Eligibility.** Tiered Multiple Points is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Must have a valid Topaz, Sapphire, Emerald or Diamond Fire Keeper's Club card to enter. Employees of Potawatomi Hotel & Casino ("PH&C") are not eligible to participate in the Promotion.
- 2. Agreement to Official Rules.** By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.
- 3. Promotion Period.** The Promotion period starts at 12:00AM and ends at 11:59PM Time (CT) on each multiplier date. PH&C's computer is the official time-keeping device for this Promotion.
- 4. How to Enter.** Qualified Topaz, Sapphire, Emerald and Diamond guests playing slots (excludes video poker slots & electronic table games) with their Fire Keeper's club card can receive 3x points. To qualify a guest must have been a Topaz, Sapphire, Emerald, or Diamond tier Fire Keeper's Club member 4 days prior to the event date.

Guests will only receive 3x points on their specific Fire Keeper's club tier date. Slots only (excludes video poker & electronic table games), Bingo and Table Game points are excluded. Multiple points don't count towards player's card status or to multiple FKC cards in use; multiple points will only apply to the initial card inserted.
