1. Eligibility.

5x points is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Fire Keeper's Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, ("PCH"). Employees of ("PCH") are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

All guests who are playing slots with their Fire Keeper's Club card can participate in the 5X multiple point's promotion. ***Bingo, Electronic Slot Table Games, Live Table Games, Sports Wagering, and Video Poker are excluded.*** Multiple points don't count towards player's card status or to multiple Fire Keeper's Club cards in use; multiple points will only apply to the initial card inserted.
